In light of recent media reports regarding the provision of employer and member superannuation details and information to third parties, we would like to re-iterate our commitment to protecting your privacy and personal information.

In addition, the Australian Privacy laws were changed on 12 March 2014 and we updated our Privacy Policy on 12 March 2014 to accommodate the changes in the law.

Summary of the National Privacy Principles

NESS Super is committed to respecting your right to privacy and protecting your personal information.

We are bound by the provisions of the Privacy Act 1988 (Cth), which contains thirteen Australian Privacy Principles which regulate how NESS Super collects, uses, discloses and keeps secure your personal information.

NESS Super Privacy Policy

The NESS Super Privacy Policy outlines the types of personal information NESS Super may need and the reasons for its collection, and explains how the information is collected, stored, used and disclosed.
